Entry Requirements:

1. Any photographer is eligible to enter his or her artwork.
2. Each artist may submit up to three (3) works, hand-delivered to Full Circle Arts.
3. Visual works must not have previously been entered in a Full Circle Arts competition.
4. Space is limited, so FCA cannot accept any work more than 48" in any direction.
5. Photographs must be prints, framed and wired for hanging.
6. Entry fee: \$15 for up to 3 entries.
7. FCA asks a commission of 20% from exhibiting members, 30% from associate and patron members, and 35% from non-members, for works sold. Full Circle Arts reserves the right to exclude any art objects which do not conform to Full Circle Arts' standards of quality or good taste.

Deliver photographs: Thu. & Fri., March 7 & 8, 11:00-5:00pm or Sat. March 9, 10:00-2:00pm, to Full Circle Arts, 42-B Third Street NW, Hickory.

Pick up photographs: Wed.- Fri., April 24-26, 11:00-5:00pm or Sat. April 27, 10:00-2:00pm

Waiver and Liability: Full Circle Arts offers insurance coverage on art works entered while they are in FCA custody, with a \$500 deductible. In order for work to be insured, a value must be declared on the FCA Inventory Sheet by the artist upon delivery of artwork. Insurance coverage for work in the show ends April 30, 2019.

Reproduction Rights: Full Circle Arts reserves the right to photograph any work for publicity or promotional purposes. All works chosen for these purposes will be credited to the artists and the artist will be informed of their use. Full Circle Arts will retain a 35% commission for non-members, 30% for FCA patron and associate members and 20% for FCA exhibiting members on any art sold during the show.
