Submitting a work of art implies an agreement on the part of the artist to the conditions set forth in this exhibition's prospectus.

**Reception:** Thursday, Oct. 26, 6:00-8:00 pm.

**Awards:** First- \$300, Second- \$200, Third- \$100    Honorable Mention ribbons, and People's Choice certificate.

### Entry Requirements:

- **Open** to all area artists sixteen (16) or older.
- **Theme:** The theme is colors, both usual and unusual, for the autumn season. All art is expected to be the original work of the submitting artist. The art may be non-objective, representational, or anything in between. Artwork may be any medium, and must be solely the original concept, design, and execution of the submitting artist.
- **Up** to three (3) works may be entered.
- **2-Dimensional:** All 2-D art must be securely wired. Works with clip mounts or sawtooth hangers not accepted. Art must be framed unless on canvas or panel with finished edges.
- **3-Dimensional:** All 3-D art must be assembled and displayed on pedestals or supports supplied by the artist.
- **Due** to gallery space and wall weight limitations, FCA cannot accept wall-hanging work more than 48" in any direction. Self-standing work must not exceed 48" horizontally.
- **Artwork** must not have previously been entered in an FCA competition.
- **Sales/Commissions**—FCA strongly encourages works be for sale. FCA will retain a 35% commission for non-members, 30% for FCA patron and associate members and 20% for FCA exhibiting members.
- **All** entries juried in must remain on display for the duration of the show.
- **FCA** reserves the right to exclude any art objects that require special installation or which do not conform to FCA's standards of quality or good taste.

**Deliver artwork:** Friday, Oct. 13, 11am - 5pm, or Saturday, Oct. 14, 10am-2pm

**Pick up artwork declined:** Thursday, Oct. 26, Friday, Oct. 27, 11am-5pm, or Saturday, Oct. 28, 10am-2pm.

**Pick up artwork accepted:** Friday, Dec. 8, 11am-5pm, or Saturday, Dec. 9, 10am-2pm.

**Entry fee:** Entry fee must be paid at time of delivery. Cash, check, credit cards are accepted. Registration fee is non-refundable. FCA exhibiting members - \$10, FCA associate and patron members - \$25, Non-members - \$35, for up to three entries.

**Waiver and Liability:** Each work must have a value declared on the entry form in order to be covered by insurance. The retail sale value listed on the form, less Full Circle Art's commission, should be the insurance value for each artwork, less a \$500 deductible. Insurance coverage for accepted work ends December 15, 2023.

**Reproduction Rights:** Full Circle Arts reserves the right to photograph any work for publicity or promotional purposes. All works chosen for these purposes will be credited to the artists and the artist will be informed of their use.
